2022-23 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Gratton School held a public hearing on September 12, 2022 and determined that each school within the District has sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs the State of California. All students are given their own individual standards aligned textbooks and/or instructional materials in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the State Department of Education, making the textbooks used in the school the most current available. Standards aligned materials are reviewed by the certificated staff and a recommendation is made to the School Board. All recommended materials are available for parent examination at the district office prior to adoption. Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and

Options
