




This chart shows the total general purpose revenue Gratton School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Gratton School District is \$2,223,939, of which \$1,724,425 is Local Control Funding Formula (LCFF), \$267,270 is other state funds, \$162,900 is local funds, and \$69,344 is federal funds. Of the \$1,724,425 in LCFF Funds, \$67,104 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).


Gratton Schools allocate other General Fund expenditures, which are not included in the LCAP, to cover a broad range of essential needs. These expenditures encompass salaries and benefits, ensuring we attract and retain high-quality staff. Additionally, funds are allocated for books and supplies to provide our students with the necessary educational materials. Services and operating expenditures are also covered to maintain smooth and efficient school operations. Furthermore, capital outlay investments are made to enhance our facilities, and other outgoing costs are addressed to support the overall functioning of our district. These strategic allocations are crucial for sustaining and advancing our educational mission.

Increased or Improved Services for High Needs Students in the LCAP for the 2024-25 School Year

In 2024-25, Gratton School District is projecting it will receive \$67,104 based on the enrollment of foster youth, English learner, and low-income students. Gratton School District plans to spend \$171,787 towards meeting this requirement, as described in the LCAP.

We're pleased to report that all metrics for the 2023-24 LCAP met their intended goals, indicating that the actions were successful. Action 1.2 was not implemented in the 2023-24 School Year as no teachers were in need of Induction Support.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The variance between Budgeted Expenditures and Estimated Actual Expenditures for Action 1.3 is due to the district purchasing supplemental resources and programs on two or three-year contracts to achieve cost savings. Although we did not spend the entire budget allocated for the 2023-24 school year, all planned supplemental resources and programs were successfully implemented.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

Action 1.1 resulted in a positive FIT report indicating great success in that goal. As described above, Action 1.2 was not carried out this year as no teachers were in need of Induction Support. Action 1.3 was successful in ensuring that all students had access to curriculum in a meaningful manner, additionally, as reported in Metric 5 from Goal 2, our fifth grade students were successful in obtaining their goal, however our eighth grade students were not.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

In the 2024-2027 LCAP, we'll be focusing on two broad goals, incorporating minor adjustments to our current goals. This revised structure will better reflect our priorities and align Actions with the approapriate Goals and Metrics (as communicated above the Action of science supplemental curriculum was in Goal 1, whereas the Metric to assess the success of Science instruction was in Goal 2). Specifically, Metrics 1, 3, and 4, along with Actions 1.2 and 1.3 will remain in Goal 1. Action 1.2 will be included within an inclusive Action of Teacher Development. We will also make some adjustments to the Metrics to better align with the California Dashboard data.

Metric 2 and Action 1.1 will be moving to Goal 2 in the 24-27 LCAP.

While our LCAP has seen inconsistent progress over the past three years, we successfully achieved the outcome for Metric 3 this year, and the achieved outcome for Metric 5 was limited to fifth graders. It's important to note that our relatively small student population can impact the ability to calculate the EL (English Learner) progress reporting in Metric 4. Additionally, with ongoing reclassification of English Learners and new student identification, language acquisition levels naturally fluctuate each year. We'll continue to monitor these factors and ensure our LCAP reflects the most accurate data available.

We're committed to analyzing the data and developing targeted strategies to improve student performance across all grade levels in the upcoming LCAP cycle.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The variance between Budgeted Expenditures and Estimated Actual Expenditures for Action 2.2 is due to salary increases and enhanced services provided to students. Action 2.3 was implemented, but its services were funded through alternative sources. The difference for Action 2.5 is attributed to purchasing Language Development resources and programs as multi-year contracts to achieve cost savings for the district. While Action 2.5 was implemented, the necessary purchases were funded from a one-time alternative funding source specific to technology.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

The latest LCAP update shows that although we have not met all our goals, we have maintained stable academic performance across most areas. Actions 2.1, 2.2, 2.3, and 2.5 continue to effectively support student achievement. Additionally, Action 2.4 has successfully kept the reclassification rate of our English Learners at the targeted level.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

In the 2024-2027 LCAP, we'll be focusing on two broad goals, incorporating minor adjustments to our current goals. This revised structure will better reflect our priorities. To promote further improvement, we will evaluate our intervention programs for at-risk students. This evaluation will help us determine necessary adjustments or additions for the next LCAP cycle, aiming to provide at-risk students with the specific support they need to succeed.

All relevant metrics in this current Goal will now fall under Goal 1, except for Metrics 2 and 6, which will be eliminated. Actions 2.2 and 2.3 will be consolidated into broader categories: Academic Interventions Tier I and Academic Interventions Tier II & III. Additionally, Action 2.4 will be integrated into a comprehensive English Learners Action, and Action 2.5 will be part of the Supplemental Curriculum Action.

We are pleased to announce that all actions under Goal 3 have been successfully implemented, with Metrics 1-7 meeting their targets for the 2023-24 LCAP.

The variance between Budgeted Expenditures and Estimated Actual Expenditures for Action 3.1 is due to necessary purchases being funded from a one-time alternative funding source specific to Professional Development. Actions 3.2 and 3.3 were implemented through School Counseling services, and expenditures will be reflected in our budget at the end of the fiscal year. The difference for Action 3.4 is attributed to the Student Information System being purchased on a multi-year contract to achieve cost savings for the district.

We are pleased to report that Metrics 1-7 successfully met their intended outcomes for the 2023-24 LCAP, demonstrating the effectiveness of Actions 3.1 through 3.4. In response to these achievements, we are committed to further enhancing our strategies. We plan to refine and strengthen our Social Emotional Development systems to build on this momentum, ensuring sustained and improved student success in these critical areas.

For the 2024-2027 LCAP, we will streamline our focus into two broad goals, reflecting refined priorities through minor adjustments to our current goals. Metric 2, having been fully integrated into our school-wide culture and systems, will no longer be tracked separately but will continue as an action under Parent Engagement & Satisfaction. Metric 7 will be removed as it is not applicable to our district, which is not a High School District.

Actions 3.1 to 3.3 will be merged into a comprehensive Social-Emotional Development Action. Similarly, Action 3.4 will be incorporated into a broader Parent Communication Action, enhancing our approach to engaging and informing our educational partners.

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Gratton School District is a rural district encompassing just five square miles, serving students from transitional kindergarten through eighth grade. The district includes two schools: Gratton Elementary and Gratton Charter. For the 2023-24 school year, the combined English Learner population at both schools is 5.8%, and 22.3% of students qualify for Free and Reduced meals. Currently, the district does not serve any foster students.

In addition to the core curriculum, all students participate in the STEAM enrichment program, and those in grades 5 through 8 engage in competitive sports. The district employs a Response to Intervention (RTI) program to support students requiring academic or behavioral assistance or differentiation. Furthermore, the district provides onsite support from a Resource Specialist and a Speech Pathologist and has recently added Mental Health Supports. All other Special Education services are provided by a regional provider.

Reflections: Annual Performance

Gratton Elementary only received status in Chronic Absenteeism and Suspension Rate on the 2023 California Dashboard, with all other data points for review falling under Gratton Charter School. For the purposes of reviewing data and determining programming, this document will reflect data points from the Charter School, with the specific areas for the Elementary School also included.

- Chronic Absenteeism Charter: Blue (Very Low) maintained at 0%
- Chronic Absenteeism Elementary: Population too small to be given a Performance Color, declined 18.8%
- Suspension Rate Charter: Yellow (Medium), declined 0.8%
- Suspension Rate Elementary: Population too small to be given a Performance Color, maintained at 0%

- English Language Arts: Green (High) at 32.4 points above the standard, an increase of 3.7 points. The state of California is ranked Low at 13.6 points below the standard.
- Mathematics: Green (High) at 17.8 points above the standard, an increase of 11.1 points. The state of California is ranked Low at 49.1 points below the standard.
- English Learner Progress: Population too small to be given a Performance Color or growth information.

When evaluating growth from the prior year in terms of Decline, Maintain, or Increase, we observed improvement in student achievement in both English Language Arts and Mathematics and maintained a 0% Chronic Absenteeism Rate. Significant effort has been dedicated to Academic Interventions over the past 5-7 years with the maintenance of our Response to Intervention Program. We recognize the increase in Suspension and will address strategies to support students in this area throughout the LCAP. It should also be noted that due to our small population, this increase is the result of one singular suspension.

After reviewing our previous LCAP, we have decided to streamline the new LCAP with two broad goals: 1) Student Academic Achievement and 2) Student Emotional Needs, inclusive of School Climate. We found that this structure better aligns our goals with actions, addressing occasional misalignments in the previous LCAP. As a result, the metrics and actions from our previous three goals will now be integrated into these two overarching goals, as detailed in our 2023-24 LCAP Annual Update.

Our educational partners have emphasized the importance of continuing to focus on English Language Arts to sustain growth and reduce the achievement gaps among at-risk student groups through academic interventions and supports. Additionally, we recognize ongoing social and emotional needs within our student population and will maintain supports to better engage students and families and address behavioral concerns.

The original outline of goals and actions was approved by our educational partners, who agreed that no additional items or modifications were needed. The plan was approved and accepted in its original format.
